TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entrants under 18 must be accompanied by an adult to play.
3. Employees (and their immediate families) of the Promoters, and agencies associated with this promotion are ineligible to enter.
